Introduction 介绍

This privacy policy ("this policy") applies to admissions and market promotion related services ("services") of any YCIS school of YEW CHUNG YEW WAH Education Network in mainland China ("school" or "we").

本隐私政策("本政策")适用于耀中耀华教育网络中国大陆任一耀中学校(以下简称"学校"或 "我们")的招生和市场宣传相关服务(简称"服务")。

We will collect, store, use, entrusted processing, co-processing, share, transfer, public disclose and deletion (Collectively referred to as "process") your and your child's personal information due to provide services to your children. We understand the importance of personal information to you and your child. We will do our utmost to protect your and your child's personal information. We are committed to abide by the following principles to protect your and your child's personal information: the principle of consistency of rights and responsibilities, the principle of clear purpose, the principle of consent on item basis, the principle of minimization & necessity, the principle of security, the principle of subject participation, the principle of openness and transparency, etc. At the same time, we promise that we will take appropriate security measures to protect your and your child's personal information in accordance with the industry's mature security standards.

In order to make this policy easy for you to understand, we try our best to explain and inform you in plain language. For the clauses and the rules for processing personal sensitive information in this policy that we consider to be materially related to your and your child's rights and interests, we've marked them in bold to draw your special attention. Please read carefully and understand this policy before you agree to this policy.

Provision of Accurate Information

You should ensure that the personal information you provide is true and accurate. We will not assume any legal liability arising from any inaccurate, unauthorized or false information that you provide. If you provide any personal information that belongs to others, you must ensure that their proper consent and authorization have been obtained.

The terms listed below shall have the meaning designated:

- 1. Personal Information refers to various information, recorded in electronic or any other forms, that is related to an identified or identifiable natural person, excluding any information that has been anonymized.
- 2. Anonymization refers to the process in which personal information is handled so that it is impossible to identify certain natural persons and that it cannot be recovered.
- 3. Personal sensitive information refers to personal information that, once leaked, illegally provided, or abused, may endanger personal and property safety, and easily lead to personal reputation, physical and mental health damage, or discriminatory treatment, including such information as biometric identification, religious belief, specific identity, medical health, financial account, whereabouts and tracks, as well as the personal information of minors under the age of 14.
- 4. Personal Information mentioned in this policy refers to the Personal Information provided by you, including the personal information of parents/guardians and students.

- 1. How we collect and use your and your child's personal information 我们如何收集和使用您及您孩子的个人信息
- 1.1 Collection of personal information 个人信息收集

We will collect your and your child's personal information when you use admissions and market promotion related services, details as below: Specially noted that personal information of minors under 14 years of age is sensitive personal information.

1) Personal Information collected by submitting the admissions enquiry form, request to schedule an open day or tour of our school, or other admission enquiry methods (such as phone, email, message etc.)

To enable us to process your child's application, arrange for assessment and interviews, we will collect the following additional Personal Information about any student you are responsible for:

1.2 How we use your and your child's personal information. 我们如何使用您及您孩子的个人信息

Throughout your use of our website and/or our provision of services to you and your child, we use your and your child's personal information for various purposes. The purposes for which we use your and your child's personal information are set out below:

- Respond to the admission enquiries.
- > Introduce the school and its education services and share such details with you and your child.
- Assess the suitability of the Applicant's admission to the school.
- Verify any information provided through the application process.
- Arrange for the visiting tour to the school or for participation in related events or activities.
- To send you newsletters relating to school.



- To comply with any regulatory, audit or security related requirements.
- Any other purposes related to the smooth running of school.

- 1.3 Exceptions

征得授权同意的例外

In accordance with the relevant laws, regulatory requirements, and national standards, we may process your and your child's personal information without seeking your separate consent or consent in any of the following circumstances:

- 1) Necessary for the school to perform its statutory duties or obligations.
- 2) Directly related to national security and national defense security.
- 3) Necessary to respond to public health emergencies, or to protect the life, health, and property safety of natural persons in emergencies.
- 4) Directly related to judicial or administrative law enforcement such as criminal investigation, prosecution, trial, and enforcement of judgments.
- 5) Your and your child's personal information is disclosed to the public on your own.
- 6) Collect or use personal information received & generated from legally and publicly disclosed information, such as legitimate news reports, government information publication or other channels.
- 7) Necessary for the performance of a contract in which the individual is a party.
- 8) Where such acts as news reporting and supervision by public opinions are carried out for the public interest, and the handling of personal information is within a reasonable scope.
- 9) Other circumstances stipulated by applicable laws and regulations.

- 6) 从合法公开披露的信息中收集个人信息的,包括合法的新闻报道、政府信息公开渠道;
- 7) 为订立、履行个人作为一方当事人的合同所必需;
- 8) 为公共利益实施新闻报道、舆论监督等行为,在合理的范围内处理个人信息;



9) 适用法律法规规定的其他情形。

2. How we use Cookie 我们如何使用 Cookie

Sometimes we will store small data files called Cookie on computers or mobile devices to make sure our services operate properly. Cookie refers to plain text files stored on a computer or mobile device by a network server, and the contents of a Cookie can only be retrieved/read by the server that created it. Each Cookie is unique to your web browser or mobile application. Cookie usually contains identifiers, site names and some numbers and characters.

为确保我们的服务正常运转,我们有时会在您的计算机或移动设备上暂时存储名为 Cookie 的小数据文件。Cookie 是一种网络服务器存储在计算机或移动设备上的纯文本文件。Cookie 的内容只能由创建它的服务器检索或读取。每个 Cookie 对您的网络浏览器或移动应用程序都是唯一的。Cookie 通常包含标识符、站点名称以及一些号码和字符。

We use Cookie to improve your experience when visiting and using our services, as Cookie enables our services to remember your single visit (using session Cookie) or multiple visits (using permanent Cookie), as well as saving your browsing settings such as language, font size, and other browsing preference on your computer or mobile devices. This means that you do not need to reconfigure your preferences each time when visiting or using our services. We do not use Cookies for purposes other than those indicated in this statement. You can manage or delete Cookies according to your preferences, or you can delete all Cookies stored on your computer or mobile device. However, please note that by doing so, you will need to change your user settings by yourself every time you visit or use our services.

我们启用 Cookie 的目的在于改善您的访问和使用服务的体验。借助于 Cookie, 我们的服务能够记住您的单次访问(使用会话 Cookie) 或多次访问(使用永久 Cookie), 并保存您的偏好设置,例如计算机或移动设备的语言、字体大小和其他浏览偏好。这意味着,您无需在每次访问或使用时重新配置用户偏好设置。我们不会将 Cookie 用于本政策所述目的之外的任何用途。您可根据自己的偏好管理或删除 Cookie。您可以清除计算机或移动设备上保存的所有 Cookie, 但如果您这么做,您将需要在下一次访问或使用我们的服务时重新配置用户偏好设置。

Analytics and advertising Cookies 分析和推广 Cookies

Analytics and advertising Cookies may collect information about how you use our school official website including details such as the website that referred you (e.g., search engines, marketing campaigns, referring domains), webpages you have visited, the website path you navigated and the links or advertisements that you have clicked on. We use this information to improve the school official website, enhance visitor experience and to make advertising messages more relevant to you and your interests. These Cookies also perform functions like preventing the same ad from continuously re-appearing.

We will also share some of this information with third parties - such as analytics and search engine providers to assist us in improving and optimizing our school official website, and advertisers to promote our services by presenting ads to you on websites that are not owned or operated by us. These advertisements are solely intended to make you aware of us. We will not sell your personal information to any third parties.

Mobile apps and WeChat public websites 移动应用程序和微信公众号

When you download and/or use one of our mobile apps or WeChat public websites, we might (to the extent permitted by your privacy settings in that apps or public websites) track and collect data about the use of the mobile apps or WeChat public websites based on your device number, such as the date and time that the mobile apps or WeChat public websites accessed our servers on your device and the information and files downloaded from mobile apps or WeChat public websites to your device.

当您下载和/或使用我们的某个移动应用程序或微信公众号,我们可能会(在该程序或公众号中您的隐私设置允许的范围内)基于您的设备编号跟踪并收集移动应用程序或微信公众号的使用数据,如您的设备上的移动应用程序或微信公众号访问我们服务器的日期和时间以及从移动应用程序或微信公众号下载至您设备的信息和文件。

3. How do we share, transfer and publicly disclose your and your child's personal information

我们如何共享、转让、公开披露您及您孩子的个人信息

3.1 Sharing or transfer 共享或转让

We will not share or transfer your and your child's personal information with companies, organizations, and individuals other than this school, except in the following cases:

- 1) With your explicit consent or active selection, we may share or transfer your and your child's personal information.
- 2) Share or transfer under legal circumstances. We may share or transfer your and your child's personal information according to laws and regulations, litigation dispute resolution needs, or requirements of administrative and judicial authorities according to law.



- 3) Where merger, acquisition or bankruptcy liquidation, or other situations involving mergers, acquisitions, or bankruptcy liquidation occurs for the school and the personal information is therefore transferred, we will request the company or organization possessing your and your child's personal information to be sequentially bound by this policy and inform you of the name and contacts of such company or organization in a timely manner. Otherwise, we will request such company or organization to obtain your consent again.
- 4) If necessary, the school may share your and your child's personal information to its affiliates or the third parties, we shall inform the personal information recipient's name, contact information, purpose of processing, method of processing and type of personal information, and shall obtain your separate consent. The school, its affiliates and the third parties will take reasonable and necessary protective measures to protect personal information under the requirements of laws and regulations.

When the school shares your and your child's personal information with external organizations or individuals, the school will add confidentiality clauses in the contract signed with it, requiring them to strictly process your and your child's personal information according to relevant confidentiality and security measures. 我们不会与本校以外的任何公司、组织和个人共享或转让您及您孩子的个人信息,但以下情况除外:

- 1) 在获得您的明确同意或授权或您主动选择的情况下共享或转让您及您孩子的个人信息;
- 2) **在法定情形下的共享或转让。**我们可能会根据法律法规规定、诉讼争议解决需要,或按 行政、司法机关依法提出的要求,对外共享或转让您及您孩子的个人信息;
- 3) 在学校发生合并、收购或破产清算情形,或其他涉及合并、收购或破产清算情形时,如 涉及个人信息转让,我们会要求新的持有您及您孩子个人信息的公司或组织继续受本 政策的约束并及时向您告知该等公司或组织的名称和联系方式,否则我们将要求该公司 或组织重新向您征求同意;

When you use our school APP, we will integrate software development kits (SDKs) provided by third parties to achieve related purposes. We will conduct strict security checks on the SDKs used by our partners to obtain information in order to ensure data security. You can refer to "Attachment 1" for understanding the data usage and protection rules of third parties.

当您使用我们的 school APP 时,我们会接入由第三方提供的软件开发包(SDK)以实现相关目的。我们会对合作方获取信息的软件工具开发包(SDK)进行严格的安全检测,以保障数据安全。您可以查看"附件一"了解第三方的数据使用和保护规则。



When you use our WeChat public websites, we will integrate software development kits (SDKs) provided by third parties to achieve related purposes. We will conduct strict security checks on the SDKs used by our partners to obtain information in order to ensure data security. You can refer to "Attachment 2" for understanding the data usage and protection rules of third parties.

当您使用我们的微信公众号时,我们会接入由第三方提供的软件开发包(SDK)以实现相关目的。我们会对合作方获取信息的软件工具开发包(SDK)进行严格的安全检测,以保障数据安全。您可以查看"<u>附件二</u>"了解第三方的数据使用和保护规则。

When you use third-party payment to complete the payment of fees, we will share order transaction information with the third party. Please refer to "Attachment 3" for details.

3.2 Public Disclose

公开披露

We will only disclose your and your child's personal information in the following cases:

- 1) With your explicit consent or active selection, we may disclose your and your child's personal information to the public.
- 2) Disclosure based on law: We may publicly disclose your and your child's personal information in the event of mandatory requirement of legal, legal procedure, litigation, or governmental agencies.

我们仅会在以下情况下,公开披露您及您孩子的个人信息:

- 1) 获得您明确同意或基于您的主动选择,我们可以公开披露您及您孩子的个人信息;
- 2) 基于法律的披露:在法律、法律程序、诉讼或政府主管部门强制性要求的情况下,我们可能会公开披露您及您孩子的个人信息。

Entrusted processing and co-processing 委托处理与共同处理

In order to provide better services to you and your child, we may authorize our related parties, vendors and service providers ("entrusted party") to provide some services to you and your child. We will only authorize the entrusted party to process your and your child's information for lawful, legitimate, necessary, specific and defined purposes.

为了更好地为您及您的孩子提供服务,我们可能授权关联方、委托供应商和服务提供商, (下称"受托方")为您及您孩子提供某些服务。我们仅会出于合法、正当、必要、特定、 明确的目的委托受托方处理您及您孩子的信息。

We will strictly limit the purposes for which the entrusted party processes information and require the entrusted party to implement adequate data security measures. We will sign requisite confidentiality agreements with our entrusted parties and require them to process personal information in accordance with our



requirements, personal information protection policies, and any other relevant confidentiality and security measures.

我们会严格限制受托方的信息处理目的并要求受托方采取充分的数据安全保障手段。我们会与受托方签署必要的保密协议,要求他们按照我们的要求、个人信息保护政策以及其他任何相关的保密和安全措施来处理个人信息。

If the entrusted party use your and your child's information for any purpose which we have not authorized, or fails to effectively perform its responsibility to protect the security of personal information, we will immediately require the entrusted party to stop the relevant actions, and to take effective remedial measures to control or eliminate the security risk to personal information, such as changing passwords, withdrawing authority, disconnecting from the network, etc. If necessary, we will terminate the business relationship with the entrusted party and request the entrusted party to delete the personal information obtained from us in a timely manner.

Under co-processing scenarios, we will sign relevant agreements with our related parties, vendors and service providers in accordance with the requirements of laws and regulations, and perform relevant personal information protection obligations.

在共同处理场景下,我们会按照法律法规要求与关联方、供应商和服务提供商签署符合法律 法规要求的相关协议,并履行相关个人信息保护义务。

5. How do we store and protect your and your child's personal information 我们如何存储和保护您及您孩子的个人信息

5.1 Storage

存储

In principle, the personal information we collect and generate within the mainland China will be stored in mainland China. But some services will be offered by suppliers abroad, so some of your and your child's personal information will be provided and stored abroad.

原则上,我们在中华人民共和国境内收集和产生的个人信息,将存储在中华人民共和国境内。但我们的部分服务由境外供应商提供,故您及您孩子的部分个人信息将会被提供和存储至境外。

Foreign jurisdictions may have different personal information protection laws or even no such laws. In such cases, we will ensure that your personal information is adequately protected to the same extent as in the mainland China.

境外辖区可能设有不同的数据保护法,甚至未设立相关法律。在此类情况下,我们会确保您的个人信息得到在中华人民共和国境内足够同等的保护。



If, due to business requirements, personal information needs to be provided or transferred to abroad institutions or individuals, the school will obtain your consent in advance, inform you of the purpose and recipient of such transfer etc., and complied with the procedure as required by the relevant laws and regulations.

如因业务需要向其他境外机构或个人提供或传输个人信息的,学校会事先征得您的同意,告知信息出境的目的、接收方等情况,并履行相关法律法规规定的程序。

The information you provide to us may be archived or stored periodically by us according to backup processes and the retention period of personal information shall be the minimum period necessary for the purposes for which it was collected, to provide our services to you, resolve disputes, establish legal defenses, conduct audits, pursue legitimate business purposes, enforce our agreements, and comply with applicable laws.

您提供给我们的信息可能会由我们根据备份流程定期存档或储存,并且保留的时间为收集该 等信息的目的、向您提供我们的服务、解决争议、建立法律抗辩、执行审计、追求合法的商 业目的、执行我们的协议和遵守适用法律所必要的最短时间。

Upon the expiration of the retention period, or your and your child's information is no longer needed for the purposes of this policy, or when it is not required to be retain in accordance with relevant laws and regulations, in addition to retaining evidence of notification and consent, the school will take reasonable steps and safe mode to remove personal information or make it unrecognizable and cannot be edited, modified or used again.

在保存期限届满或您及您孩子的信息已经不再需要用于实现本隐私政策规定的目的和用途, 也无需根据相关法律法规的规定保存时,除留存告知和同意的证据外,学校将采取合理步骤 以安全的方式销毁个人信息或使其不可识别并不可被再次编辑、修改、使用。

5.2 Protection 保护

We have used industry-standard security measures to protect the personal information (include children and minors) you provide to prevent unauthorized access, public disclosure, use, modification, damage or loss of data. We will take all reasonable and feasible actions to protect your and your child's personal information. For example, when you exchange data between your browser and the "service", you are protected by SSL encryption; in the meantime, we also provide https secure browsing for school website; we will use trusted protection mechanisms to protect against malicious attacks; we deploy access control mechanisms to ensure that only authorized personnel have access to personal information; and we conduct security and privacy protection training courses to enhance employee awareness of the importance of protecting personal information.

合理可行的措施,保护您及您孩子的个人信息。例如:在您的浏览器与"服务"之间交换数据时受 SSL 加密保护;我们同时对学校网站使用 https 安全浏览方式;我们会使用受信赖的保护机制防止数据遭到恶意攻击;我们会部署访问控制机制,确保只有授权人员才可访问个人信息;以及我们会举办安全和隐私保护培训课程,加强员工对于保护个人信息重要性的认识等。

We have established special management systems, procedures, and organizations to ensure the security of information. We strictly limit the scope of persons who can access the information, require them to undertake confidentiality obligations. 我们建立专门的管理制度、流程和组织以保障信息的安全,严格限制访问信息的人员范围,要求他们遵守保密协议。

The internet is not an absolutely secure environment. Please use complex passwords and do not disclose your and your child's personal information to others to help us keep your account secure. Any leakage of personal information resulting from the disclosure of your password to or sharing of your account with others by yourself, we shall not undertake legal liabilities.

互联网并非绝对安全的环境,请使用复杂密码,不向其他人透漏您及您孩子的个人信息,以协助我们保护您的账号安全。由于您将用户密码告知他人或与他人共享注册账户所导致的任何个人信息泄露,我们不承担任何法律责任。

The Internet environment is not 100% secure, and we will do our best to ensure or guarantee the security of any information you send to us. If our physical, technical, or administrative protection is damaged, which results in unauthorized access, public disclosure, alteration, or destruction of information and further impairs your legitimate right, we would undertake corresponding legal liabilities. 互联网环境并非百分之百安全,我们将尽力确保或担保您发送给我们的任何信息的安全性。如果我们的物理、技术或管理防护设置遭到破坏,导致信息被非授权访问、公开披露、篡改或者毁坏,导致您的合法权益受损,我们将承担相应的法律责任。

In accordance with the requirements of laws and regulations, in the occurrence of any personal information security incident (including information loss, damage, leakage, tampering etc.), we will promptly notify you of the following in accordance with laws and regulations: basic information about the security incident and its potential impact, treatment measures we have taken or will take, suggestions about proactive defense and risk mitigation, remedial measures etc. We will promptly let you know the relevant situations of the incident by means of mail, letter, phone call, push notification etc. We will issue announcements in a reasonable and effective manner when having difficulty in reaching out to each personal information subject.

按照法律法规的要求,在您的个人信息不幸发生遗失、损毁、泄露或被篡改等安全事件后,我们将及时向您告知安全事件的基本情况和可能的影响、我们已采取或将要采取的处置措施、您可自主防范和降低风险的建议、对您的补救措施等。我们将及时将事件相关情况以邮件、信函、电话、推送通知等方式告知您,难以逐一告知个人信息主体时,我们会采取合理、有效的方式发布公告。



Meanwhile, we will also report the handling status of personal information security incidents as required by regulatory authorities.

6. Your Rights 您的权利

In accordance with mainland China's relevant laws, regulations, standards, and the common practice of other countries and regions, we guarantee you the following rights of your and your child's personal information:

按照中国相关法律、法规、标准,以及其他国家、地区的通行做法,我们保障您对您及您孩 子的个人信息行使以下权利。

6.1 Access to your and your child's personal information 访问您及您孩子的个人信息

You are authorized to access your and your child's personal information, except for some circumstances stipulated by law and regulations. You could, after identity verification, exercise your right of data access through the following methods:

- 1) If you want to access your and your child's **personal information**, you can login related system by system account and password.
- 2) If you are unable to access your and your child's personal information via the method above, you can always contact us through the contact information at the end of this policy. We will respond to your request within 15 business days.
- 3) We will provide you with other personal information generated during your use of our services so long as it is within the scope of our services.

您有权访问您及您孩子的个人信息,法律法规规定的例外情况除外。在验证您的个人身份后, 您可以通过以下方式行使数据访问权:

- 1) 如果您希望访问您及您孩子的**个人信息**,您可以通过使用您的用户名和密码登录到相关 系统进行查看:
- 2) 如果您无法通过上述方式访问您及您孩子个人信息,您可以随时使用本政策文末的联系方式与我们联系。我们最迟在15个工作日内回复您的访问请求;
- 3) 对于您在使用我们的服务过程中产生的其他个人信息,我们会在业务服务范围内向您提供。

6.2 Correct your and your child's personal information. 更正您及您孩子的个人信息

When you identify any error in your and your child's personal information by our process, you are entitled to require us to make the correction. You can raise a correction application by using the methods listed in "(6.1) Access to your and your child's personal information".

当您发现我们处理的关于您及您孩子的个人信息有错误时,您有权要求我们做出更正。您可以通过"6.1访问您及您孩子的个人信息"中罗列的方式提出更正申请。

6.3 Delete your and your child's personal information.



删除您及您孩子的个人信息

Under the following circumstances, you can request us to delete your and your child's personal information:

- 1) If our processing of personal information violates any law or regulation.
- 2) If we collect or use your and your child's personal information without your consent, or if you withdraw your consent.
- 3) If our processing of personal information breaches our agreement with you;
- 4) If you no longer use our services, or you cancel your account.
- 5) If we no longer provide services to you.

在以下情形中,您可以向我们提出删除您及您孩子个人信息的请求:

- 1) 如果我们处理个人信息的行为违反法律法规;
- 如果我们收集、使用您及您孩子的个人信息,却未征得您的同意,或者您撤回了您的同意;
- 3) 如果我们处理个人信息的行为违反了与您的约定;
- 4) 如果您不再使用我们的服务,或您注销了账号;
- 5) 如果我们不再为您提供服务。

Where the storage period stipulated by law or administrative regulation has not expired, or deletion of personal information is technically hard to accomplish, we will cease the processing of personal information other than storing and taking necessary security protection measures for such information. We will respond to your request of deletion in accordance with applicable laws or regulations, we will also notify the entity(ies) which obtained your and your child's personal information from us and request them to delete such information in a timely manner, unless otherwise stipulated under laws or regulations, or if these entity(ies) has(have) obtained your separate authorization.

法律、行政法规规定的保存期限未届满,或者删除个人信息从技术上难以实现的,我们会停止除存储和采取必要的安全保护措施之外的处理。我们会根据适用的法律法规来响应您的删除请求,我们还将同时通知从我们获得您及您孩子的个人信息的实体,要求其及时删除,除非法律法规另有规定,或这些实体获得您的独立授权。

When you delete information from our service system, we may not immediately delete the corresponding information in our backup system immediately, but we will delete it when the backup is updated. In the meantime, we can retain the evidence of notification and consent.

If you want to delete your and your child's personal information, you can always contact us through the contact information at the end of this policy.

如果您想删除您及您孩子的个人信息, 您可以随时使用本政策文末的联系方式与我们联系。

6.4 Change your authorization scope.

改变您授权同意的范围



Each business function requires certain basic personal information to be provided. You could grant or withdraw your authorization & consent at any time for the collection and use of the additionally collected personal information.

每个业务功能需要一些基本的个人信息才能得以完成。对于额外收集的个人信息的收集和使 用,您可以随时给予或收回您的授权同意。

If you want to change your authorization scope, you can always contact us through the contact information at the end of this policy.

如果您想改变您授权同意的范围, 您可以随时使用本政策文末的联系方式与我们联系。

When you withdraw your consent, we will no longer process your corresponding personal information. However, this decision to withdraw your authorization will not affect personal information processing upon your previous authorization. 当您收回同意后,我们将不再处理相应的个人信息。但您收回同意的决定,不会影响此前基于您的授权而开展的个人信息处理。

6.5 Account Cancellation 个人信息主体注销账户

If you want to cancel your previously registered accounts, you can always contact us through the contact information at the end of this policy. 如果您想注销此前注册的账户,您可以随时使用本政策文末的联系方式与我们联系。

Upon cancellation of your account, we will stop providing services to you and your child and, at your request, we will delete your and your child's personal information, except as otherwise required by law or regulation, and the retention of evidence of notification and consent.

在注销账户之后,我们将停止为您及您孩子提供服务,并依据您的要求,删除您及您孩子的 个人信息,法律法规另有规定的,以及留存告知和同意的证据除外。

6.6 Personal information owners obtain copies of their personal information 个人信息主体获取个人信息副本

You have the right to obtain a copy of your and your child's personal information, you can always contact us through the contact information at the end of this policy.

您有权获取您及您孩子的个人信息副本,您可以随时使用本政策文末的联系方式与我们联系。

6.7 Constraint information systems automated decision making 约束信息系统自动决策

In some business functions, we may make decisions based on non-human automated decision-making mechanisms, including information systems, algorithms, etc. If these decisions affect your legal rights, you have the right to seek an explanation from us and we will provide appropriate remedies.



在某些业务功能中,我们可能仅依据信息系统、算法等在内的非人工自动决策机制作出决定。如果这些决定影响您的合法权益,您有权要求我们作出解释,我们也将提供适当的救济方式。

6.8 Responding to your above request. 响应您的上述请求

For security reasons, you may need to provide a written request or prove your identity when you make inquiries, submit for changes, deletion of your Information, change authorization scope and account cancellation. We may ask you to verify your identity before processing your request. We will respond to you within 15 business days.

为保障安全,您申请查询、变更、删除信息、变更授权、注销账户时可能需要提供书面请求,或以其他方式证明您的身份。我们可能会先要求您验证自己的身份,然后再处理您的请求。 我们将在15个工作日内做出答复。

Even if we delete your and your child's personal information upon your request or you successfully withdraw your authorization, we still have the right to retain and use anonymized data that we have collected based on your earlier authorization. Such anonymized data will not be personally identifiable.

即使我们应您的要求删除了您及您孩子的个人信息,或者您成功地撤回了您的授权,我们仍然有权保留和使用我们根据您先前的授权收集的匿名数据。该等匿名数据不会识别个人身份。

In principle, we do not charge for your reasonable request, however, for those repetitive, beyond reasonable requests, we may charge a fee as appropriate. For those unreasonably repetitive requests which need too excessive technical means (for example, need to develop new systems or fundamentally change existing practices), pose risks to others' legal rights, or are very impractical (for example, involving information stored on backup tapes), we may reject such requests.

对于您合理的请求,我们原则上不收取费用,但对多次重复、超出合理限度的请求,我们将视情况收取一定成本费用。对于那些无端重复、需要过多技术手段(例如,需要开发新系统或从根本上改变现行惯例)、给他人合法权益带来风险或者非常不切实际(例如,涉及备份磁带上存放的信息)的请求,我们可能会予以拒绝。

We will not be able to respond to your request in the following cases:

- 1) In connection with the fulfillment of obligations under laws and regulations by the controller of personal information.
- 2) Directly related to national security, national defense security.
- 3) Directly related to public safety, public health, and vital public interests.
- 4) Directly related to criminal investigation, prosecution, trial and execution of judgments, etc.
- 5) Where the controller of personal information has sufficient evidence of subjective malice or abuse of rights by the owner of the personal information.



- 6) For the purpose of safeguarding the life, property and other significant legitimate rights and interests of the owner of personal information or other individuals but where it is difficult to obtain the consent of the owner.
- 7) When responding to the request of the owner of personal information will result in serious damage to the legitimate rights and interests of the owner of personal information or other individuals or organizations.
- 8) Where commercial secrets are involved.

在以下情形中, 我们将无法响应您的请求:

- 1) 与个人信息控制者履行法律法规规定的义务相关的;
- 2) 与国家安全、国防安全直接相关的;
- 3) 与公共安全、公共卫生、重大公共利益直接相关的;
- 4) 与刑事侦查、起诉、审判和执行判决等直接相关的;
- 5) 个人信息控制者有充分证据表明个人信息主体存在主观恶意或滥用权利的;
- 6) 出于维护个人信息主体或其他个人的生命、财产等重大合法权益但又很难得到本人同意的;
- 7) 响应个人信息主体的请求将导致个人信息主体或其他个人、组织的合法权益受到严重 损害的;
- 8) 涉及商业秘密的。
- 7. Rules for processing personal information of about minors (children) under the age of 14

涉及14岁以下未成年人(儿童)的个人信息的处理规则

The school understands that the personal information of the pupils it collects and uses may be minors under the age of 14 ("Children"). The school places great importance to the protection of Children's personal information. The school responsibility in protection of Children's personal information will be fulfilled strictly comply with the relevant laws, regulations, and rules. The school agrees to the following:

学校了解,学校所收集、使用的学生的个人信息可能不满 14 周岁的未成年人("儿童")。 学校非常重视对儿童个人信息的保护,学校将严格按照相关法律法规规定,落实儿童个人信息保护责任,并作出如下承诺:

- 2) Before collecting Children's personal information, the school will remind parents or guardians of the Children to read this policy and inform them about the collect, store, entrusted processing, co-processing, use, share, transfer, public disclose and deletion of Children's personal information in accordance with relevant laws and regulations.



在收集儿童个人信息前,学校将提醒儿童的父母或监护人阅读本隐私政策,按照相关法律法规规定向其告知学校收集、存储、委托处理、共同处理、使用、共享、转让、公开披露和删除儿童个人信息的有关事项。

- 3) The school will only collect and use Children's personal information in strict compliance with the relevant laws and regulations and this policy provided that authorization and consent of the Children's parent or guardian has been obtained. The school will not collect Children's personal information unrelated to the operation of the school. If we find that we have collected personal information from a Children without the prior consent of the Children's parent or guardian, we will try to delete the relevant data as soon as possible. 学校将仅在获取儿童父母或监护人授权同意的前提下,严格按照相关法律法规和本隐私政策的规定收集、使用儿童个人信息,学校不会收集与学校运营无关的儿童个人信息。如果我们
- 4) The school will store Children's personal information in the manner and within the time limit specified in paragraph 1/2/3/4/5 of this policy. The school will not store Children's personal information beyond the time limit necessary for the purpose of collection and use.

5) The school will not use Children's personal information in violation of the relevant laws and regulations or the agreed purpose and scope. If it is necessary to use the personal information beyond the agreed purpose and scope to facilitate school operation, the school will obtain the consent of the Children's parent or guardian again.

学校不会违反相关法律法规规定或约定的目的、范围使用儿童个人信息。如果因学校运营需要,确需超出约定的目的、范围使用的,学校会再次征得儿童父母或监护人的同意。

- 6) The school will set up strict personal information access authority and control the scope of awareness on Children's personal information based on the principle of minimum authorization.

- 7) Children and their parents or guardians enjoy the rights as specified in Paragraph 6 of this policy.

- 8) The school will designate an officer to be responsible for the protection of Children's personal information. If you have any questions, you can always contact us through the contact information at the end of this policy.

8. How we update this policy 本政策如何更新

As we provide more information and services and as privacy laws and regulations change, we may need to revise or update this policy from time to time. But we will not undermine your rights entitled under this policy without your explicit consent. We will notify you of changes to this policy through announcements/notifications, etc.

随着我们提供更多信息和服务,以及隐私法律、法规的变化,我们会需要不时地修改或更新本政策,但未经您明确同意,我们不会削减您按照本政策所应享有的权利。我们会通过发布/通知等方式使您了解本政策所做的变更。

For significant changes, we also provide more noticeable notices (we will send a notification via email stating the specific changes to this policy). If you do not agree with the updated terms and conditions or have any doubts about this updated policy, please contact us through the contact information at the end of the policy.

Significant changes referred hereunder include but not limited to:

- 1) Major changes in our service model, such as changes in relations to the purpose of processing personal information, the way in which personal information is used, etc.
- Significant changes to our ownership structure, organizational structure, etc. such as changes of ownership due to business restructuring, acquisitions, or insolvency, etc.
- 3) Changes in the main objects of personal information sharing, transfer, or public disclosure.
- 4) Major changes in your rights to participate in the processing of personal information and the way you exercise such rights.
- 5) Changes in the department, contact information and complaint channels responsible for personal information security.
- 6) Personal information security impact assessment report indicates that there is a high risk.

对于重大变更,我们会提供更为显著的通知 (我们会通过电子邮件发送通知,说明本政策的 具体变更内容)。如果您不同意更新后的条款内容或对新的隐私政策有任何疑问,可使用本 隐私政策文末的联系方式与我们联系。

本政策所指的重大变更包括但不限于:
